Key Points in Firestopping

In this one-hour seminar, the basics of life safety design and how to design a code compliant firestopping installation into projects will be covered. Further, this course covers major issues in design such as coordination for the trades, data cabling, plastic pipes, "simple" through penetrations, construction joints and curtain walls.

- Learn the types of penetrations by trade.
- Understanding of the UL System approach to managing the firestop process.
