# Accounting for Thermal Degradation of Continuous Insulation in Facade Support Systems Specifier Roundtable: Thursday, March 2, 2017



**Robert J. Krawczyk | Professor & Associate Dean Academic Affairs**



Robert Krawczyk is a Professor and Associate Dean of Academic Affairs at the College of Architecture at the Illinois Institute of Technology focusing on digital craftsmanship. During his thirty-three years at IIT, he has developed and taught a series of computer-aided design and digital design courses. His research into digital methods in the disciplines of science, mathematics, architecture, art, and technology has been published and presented internationally in the form of prints, web pieces, sculptural, and architectural studies presented in a body of work spanning over one-hundred exhibitions, thirty-seven conference papers, multiple book chapters, and a textbook. He is a graduate of University of Illinois Chicago, College of Architecture. In the 1970's he pioneered digital graphic and architectural applications in the office of Murphy/Jahn under design partners Gene Summers and Helmut Jahn.

**David Mwale Ogoli, Ph.D. | Professor & Chair**



David Mwale Ogoli teaches studio-based sustainable design and environmental control systems in buildings. His areas of emphasis are design with climate, thermal comfort, energy-efficiency, architectural lighting and architectural acoustics. He vigorously pursues academic research and practice in the physics of heat, light and sound as applied to buildings. He has numerous articles published widely in refereed journals on subjects that include passive solar strategies, natural ventilation, natural daylighting, energy-efficiency and building control systems. He has previously served as an invited external scholar at the University of Florida and a Visiting Critic in the Department of Architecture at Cornell University in New York. Dr. Ogoli brings a rich academic and cultural heritage to his work from European and African academe gathered from the University of Cambridge and the University of Nairobi. He is a registered architect in Kenya. His current project is writing a full-length textbook on architectural science (environmental building control systems) and sustainable design.


#### **Tristan d'Estree Sterk | Associate Professor**

In particular the office is recognized for developing structural shape change technologies that alter the way that buildings use energy. The office's mission is to develop the knowledge, systems and state-of-the-art products that support tomorrow's building construction sector while enabling people to craft more responsive connections between construction systems, design, users and the natural environment. The first product produced by the office is called Formsolver, to be launched shortly.

## Hot Tip of the Month Plan Your Exit Strategy

### Collaborate Early with the Owner, and the Experts

Early and often. That's the way Chicago votes, and the way our industry should address egress planning and access control.

Besides meeting long-term performance goals, early collaboration between stakeholders of a project's egress strategy and access control plan will minimize code violations, time delays and unexpected budget overruns during construction. Competing codes (NFPA 101 Life Safety, ADA, IBC, Chicago Building Code, AHJ, etc) governing the door opening have enormous potential to conflict with the designer's aesthetic vision, and the owner's vision for security, access and budget goals.



"I like to get together with the Owner and Architecture/engineering team during Design Development," explains John Cohrs, AHC CDC CCPR, Specifications Writer, Hager Companies. "Without the owner's input on how those openings will be used, and an understanding of the owner's vision for security, and their budget, we are really just making assumptions. We need to know how most people will access the building, the frequency, what openings might need access control or delayed egress and how will it be monitored; the list of scenarios is endless and it takes experience to engage the owner and ask the right questions."

## Hot Tip of the Month (Cont.)

With so much input and guidance required to specify all that a construction project requires, access control and egress are often an afterthought. Ideally, egress and access control should be discussed during the Design Development phase; definitely before Procurement phase. For sure, you will want to avoid specifying, or even installing electric strikes on fire-rated openings that are in an egress path; or, running wires through a school's exit doors when wire free electronic locks might be more secure and cost-effective in the long run. Without directed collaboration it is easy to duplicate door hardware, and without specifying which entity is responsible for procuring the electrified hardware, the hardware supplier, door supplier, the local integrator, electrician, or a security consultant, you will run into conflicts on the jobsite.

"Early collaboration with everyone in one room is a 'wish list,' unfortunately it nearly never happens," says Dale Padjen, President, Electronic Security Solutions, Inc. (ESS). "There are so many things going on for the architect, it becomes too much to build in an egress and access planning meeting with the owner, us and the hardware consultant."

As a provider Salto Systems, a wire free and wireless access control solution, ESS typically is brought in by the owner who is thinking about flexibility, enhanced security and long-term cost-efficiency. It can be challenging to come late to the party, after wire runs and mechanical locks have already been built into Division specifications by the architect. And, if Division 08 is not coordinated properly with Division 26 (electrical) and Division 28 (access control and fire alarm systems), your project's mistakes become costlier.

According to John W. O'Neil, CSI, CCS, CCCA, LEED AP, Construction Specifier, Larson & Darby, the key is getting the owner involved in a conversation with the A/E during Design Development, and document the meeting results: "We really need to know how the owner expects the building/space to function on a day-to-day basis, as well as what the Codes and regulations dictate. Are doors normally open or normally closed? Is it a public building? Or, do you only want access available for use by a select few? For example, is it a courthouse building, where you have to separate the public from the judges and their staffs, and separate all of them from the flow of prisoners on trial?"

Access scenarios can get quite complex, but suddenly when it comes to Project Delivery and the door doesn't perform as the owner envisioned, the mistakes revealed seem very obvious, and sometimes quite costly.

Remembering a scenario early in his career, Elias Saltz, CSI, CCS, LEED AP, SCIP, Specifications Consultant with ArchiTech, can now see his overly confident decisions about access control issues required post-delivery changes on a synagogue's main point of entry:

## Hot Tip of the Month (Cont.)

“Architects should be humble about what we don’t know, we can’t be experts on everything. We bring in the experts, a hardware consultant and an access control specialist, as early as possible to sit with the owner and troubleshoot different scenarios.”

### THE SIX C’s OF ACCESS/EGRESS PLANNING:

1. **COLLABORATE:** Make a collaborative egress planning meeting with the Owner a project priority and requirement during Design Development
2. **CONSULT:** Develop relationships with a variety of trusted Hardware Consultants, Access Control and Security specialists now to ensure you have help when you need it. Most will provide these services on a complimentary basis.
3. **CODES:** Have an understanding/or access to expertise in building codes to determine Occupancy requirements for location of fire-rated openings, and safe egress openings.
4. **CREATE:** Draft an egress plan and visually walk owners through openings and ask: how do you need this door to perform? Is there a clear path of egress? Is it a fire door? Does access need to be limited, and/or audited?
5. **COLOR CODE** the plan based on the results of the collaborative meeting
6. **COVER...:** After the meeting write a clear, concise, correct, complete and coordinated performance narrative to be reviewed and approved by project stakeholders to ensure all agree, and every scenario has been addressed.
7. **COORDINATE:** Consider and coordinate with budgets, building lifecycle (warranties), and AHJ/Codes. Coordinate again upon review of submittals.

## The Closeout Whirlpool Global Headquarters

Three-building renovation & expansion

Location: Benton Harbor, Michigan

Size: 32,800 sf

Epstein served as the architect and engineer for the renovation and expansion of the Whirlpool Global Headquarters located on a campus of approximately 132 acres located on M-63 in Benton Harbor, Michigan. The Whirlpool Global HQ is composed of three buildings totaling 282,350 square feet constructed between 1955 and 1983.

In the North Wing, which includes the Boardroom as well as the offices of the CEO and the Senior Leadership Team, Epstein renovated the interior and added 1,800 sf of new space for a Boardroom and new Executive offices. Epstein also designed all new MEP systems supported by a central plant.

For the South Wing, Epstein's architects and engineers added a new lobby addition to expand and upgrade the entry. In addition, Epstein moved the auditorium and cafeteria from level 2 to the ground floor next to the lobby giving these important spaces a high profile.
